



## REVIEW OF EPA COMPLIANCE AND ENFORCEMENT - INDUSTRY CONSULTATION

EPA Victoria has appointed Stan Krpan, the former Director of Legal Services and Investigations at WorkSafe to conduct an independent review of EPA compliance and enforcement. As part of this review, a comprehensive assessment will be undertaken of how the EPA encourages industry to comply and how it enforces against those that don't.

The review aims to position EPA to meet the community's expectations for enforcing Victoria's *Environment Protection Act 1970*. It aims to ensure credible deterrents and penalties are applied where breaches occur. While the review will look at the framework and the adequacy of the tools currently available, amending the current legislation does not form part of that review. The review will result in recommendations for EPA's approach to compliance and enforcement and to its enforcement policy
